A meeting of the Members of the **Owasco Lake Watershed Management Council, Inc.** was convened on **March 15, 2016 at 10:00 A.M.** at Cayuga County Office Building, Caucus Room 1, 160 Genesee Street, Auburn, NY 13021 and the following resolution was duly offered and seconded to wit:

AMENDMENT OF THE BYLAWS OF THE OWASCO LAKE WATERSHED MANAGEMENT COUNCIL TO MODIFY THE COMPOSITION OF MEMBERSHIP

WHEREAS, pursuant to Section 1411 of the Not-for-Profit Corporation Law (“N-PCL”, and hereinafter referred to as the “Act”), and a Certificate of Incorporation (the “Certificate”) filed with the New York Secretary of State on the 23rd day of February, 2011, the **Owasco Lake Watershed Management Council, Inc.** (the “Corporation”) has been established as a not-for-profit, local development corporation to relieve and reduce unemployment, promote and provide for additional and maximum employment, improve and maintain job opportunities, instructing or training individuals to improve or develop their capabilities for such jobs, carrying on scientific research for the purpose of aiding a community or geographical area by attracting new industry to the community or area or by encouraging the development of, or retention of, an industry in the community or area, lessening the burdens of government and acting in the public interest, including undertaking programs and activities in furtherance of managing, monitoring and protecting the water resources of Owasco Lake and the water resources within the Owasco Lake Watershed for the well-being and benefit of the residents of the County; and

WHEREAS, the Town of Locke, in a Resolution passed by the Town Board of Locke, N.Y. on February 11, 2016, has declared its intent to become a Member of the Corporation and authorized and appointed Locke Town Board Member, Ms. Mary Alice Stetz, to represent the Town of Locke as a Member of the Corporation; and

WHEREAS, the By-Laws of the Corporation pursuant to Article II, Section 1 allow that additional Members of the Corporation may be added by majority vote of the current Members; and

WHEREAS, the Members of the Corporation wish to add the Town of Locke as a Member of the Corporation and thereby advance the Corporation's goal of increasing the Membership and active participation of municipalities located within the Owasco Lake Watershed, expand representation within the Watershed and strengthen the Owasco Lake Watershed Management Council's collective voice on Watershed protection, preservation and improvement; **NOW**

THEREFORE, BE IT RESOLVED by the Members of the Corporation, as follows



Section 2: That this Resolution shall be in effect immediately upon Board Approval.




