RESOLUTION TO FORMALLY REQUEST A MONTHLY REPORT FROM THE NEW YORK STATE DEPARTMENT OF ENVIRONMENTAL CONSERVATION REGARDING STATE FUNDED PROJECTS IN THE OWASCO LAKE WATERSHED

MOTION BY: EO

WHEREAS, pursuant to Section 1411 of the Not-for-Profit Corporation Law (“N-PCL”, and hereinafter referred to as the “Act”), and a Certificate of Incorporation (the “Certificate”) filed with the New York Secretary of State on the 23rd day of February, 2011, the **Owasco Lake Watershed Management Council, Inc.** (the “Corporation”) has been established as a not-for-profit, local development corporation to relieve and reduce unemployment, promote and provide for additional and maximum employment, improve and maintain job opportunities, instructing or training individuals to improve or develop their capabilities for such jobs, carrying on scientific research for the purpose of aiding a community or geographical area by attracting new industry to the community or area or by encouraging the development of, or retention of, an industry in the community or area, lessening the burdens of government and acting in the public interest, including undertaking programs and activities in furtherance of managing, monitoring and protecting the water resources of Owasco Lake and the water resources within the Owasco Lake Watershed for the well-being and benefit of the residents of the County; and

WHEREAS, improved organizational and public awareness of State-funded local water quality initiatives can improve organizational directives and access to related resources,

NOW, THEREFORE, BE IT RESOLVED by the Members of the Corporation that the Corporation will request a monthly report from the New York State Department of Environmental Conservation on state funded projects within the Owasco Lake Watershed.


