A meeting of the Members of the **Owasco Lake Watershed Management Council, Inc.** was convened on **June 11, 2013 at 10:00 A.M.** at Cayuga County Office Building, Caucus Room 1, 160 Genesee Street, Auburn, NY 13021 and the following resolution was duly offered and seconded to wit:

AMENDMENT OF THE BYLAWS OF THE OWASCO LAKE WATERSHED MANAGEMENT COUNCIL TO ADD THE AGRICULTURAL EDUCATOR FOR CORNELL COOPERATIVE EXTENSION OF CAYUGA COUNTY AS AN EX-OFFICIO, NON-VOTING DIRECTOR

WHEREAS, pursuant to Section 1411 of the Not-for-Profit Corporation Law (“N-PCL”, and hereinafter referred to as the “Act”), and a Certificate of Incorporation (the “Certificate”) filed with the New York Secretary of State on the 23rd day of February, 2011, the **Owasco Lake Watershed Management Council, Inc.** (the “Corporation”) has been established as a not-for-profit, local development corporation to relieve and reduce unemployment, promote and provide for additional and maximum employment, improve and maintain job opportunities, instructing or training individuals to improve or develop their capabilities for such jobs, carrying on scientific research for the purpose of aiding a community or geographical area by attracting new industry to the community or area or by encouraging the development of, or retention of, an industry in the community or area, lessening the burdens of government and acting in the public interest, including undertaking programs and activities in furtherance of managing, monitoring and protecting the water resources of Owasco Lake and the water resources within the Owasco Lake Watershed for the well-being and benefit of the residents of the County; and

WHEREAS, the Members of the Corporation pursuant to the Certificate, desire to amend the adopted By-laws of the Corporation to include the Agricultural Educator for Cornell Cooperative Extension of Cayuga County as an Ex-Officio, Non-Voting Director, such proposed By-laws Amendment being attached hereto as **Exhibit A**;

NOW, THEREFORE, BE IT RESOLVED by the Members of the Corporation as follows:

Section 1. Article III, Section 2(h) of the Corporate Bylaws of the Owasco Lake Watershed Management Council Inc., are hereby amended to include the Agricultural Educator for Cornell Cooperative Extension of Cayuga County as an Ex-Officio, Non-Voting Director,

(h) The following representatives, or their designees, from each of the following departments, agencies or organizations shall serve as Ex-officio Directors on the Owasco Lake Watershed Management Council Inc. Board of Directors: the Executive Director of the Cayuga County Soil and Water Conservation District, the Director of the Cayuga County Health Department Environmental Health Division, the Director of the Cayuga County Planning & Economic Development Department, the Chair of the Cayuga County Water Quality Management Agency (WQMA), the Chair of the Cayuga County Board of Health, the Chief Operator, City of Auburn Water Treatment, the Agricultural Educator for Cornell Cooperative Extension of Cayuga County, and the President of the Owasco Lake Watershed Association (OWLA). These Ex-officio Directors shall not be voting Directors and shall not count toward the number of voting Directors identified in Section 2(a) of this Article.

Section 2. This resolution shall take effect immediately.

AMENDMENT TO:

ARTICLE III – BOARD OF DIRECTORS

SECTION 2 – NUMBER, ELECTION AND TERM OF DIRECTORS

AMENDEND BY:

ADDING NEW § (h): Ex-Officio Members:

(h) The following representatives, or their designees, from each of the following departments, agencies or organizations shall serve as Ex-officio Directors on the Owasco Lake Watershed Management Council Inc. Board of Directors: the Executive Director of the Cayuga County Soil and Water Conservation District, the Director of the Cayuga County Health Department Environmental Health Division, the Director of the Cayuga County Planning & Economic Development Department, the Chair of the Cayuga County Water Quality Management Agency (WQMA), the Chair of the Cayuga County Board of Health, the Chief Operator, City of Auburn Water Treatment, the Agricultural Educator for Cornell Cooperative Extension for Cayuga County, and the President of the Owasco Lake Watershed Association (OWLA). These Ex-officio Directors shall not be voting Directors and shall not count toward the number of voting Directors identified in Section 2(a) of this Article.
