AMENDMENT OF THE BYLAWS OF THE OWASCO LAKE WATERSHED MANAGEMENT COUNCIL TO MODIFY THE COMPOSITION OF MEMBERSHIP

WHEREAS, pursuant to Section 1411 of the Not-for-Profit Corporation Law ("N-PCL", and hereinafter referred to as the "Act"), and a Certificate of Incorporation (the "Certificate") filed with the New York Secretary of State on the 23rd day of February, 2011, the Owasco Lake Watershed Management Council, Inc. (the "Corporation") has been established as a not-for-profit, local development corporation to relieve and reduce unemployment, promote and provide for additional and maximum employment, improve and maintain job opportunities, instructing or training individuals to improve or develop their capabilities for such jobs, carrying on scientific research for the purpose of aiding a community or geographical area by attracting new industry to the community or area or by encouraging the development of, or retention of, an industry in the community or area, lessening the burdens of government and acting in the public interest, including undertaking programs and activities in furtherance of managing, monitoring and protecting the water resources of Owasco Lake and the water resources within the Owasco Lake Watershed for the well-being and benefit of the residents of the County; and

WHEREAS, the Members of the Corporation pursuant to the Certificate, desire to amend the adopted By-laws of the Corporation to change the Cayuga County legislative representative from Chairman, Cayuga County Legislature ex-officio to Chairman or Member of the Cayuga County Legislature ex officio as appointed by the Chairman, Cayuga County Legislature and approved by the Cayuga County Legislature, more specifically outlined in **Exhibit A** attached hereto and made a part hereof;

NOW, THEREFORE, BE IT RESOLVED by the Members of the Corporation as follows:

Section 1. The Corporate Bylaws of the Owasco Lake Watershed Management Council Inc., are hereby amended to include the following language to be inserted into the duly adopted Bylaws as Article II, Section 1:

Article II, Section 1. – COMPOSITION OF MEMBERSHIP.

The Members of the Corporation shall be comprised of the following individuals, ex officio:

Chairman or Member of the Cayuga County Legislature as appointed by the Chairman, Cayuga County Legislature, as approved by the Cayuga County Legislature, ex officio

Supervisor, Town of Owasco, ex officio

Mayor or City Council Member, City of Auburn, as approved by the City Council of the City of Auburn, ex officio

Additional Members of the Corporation may be added from time to time by majority vote of the then-existing Members of the Corporation.

The Corporation shall be managed by its Board of Directors in accordance with the provisions contained herein.

Section 2. This resolution shall take effect immediately.
